# LNFOD TERMS OF REFERENCE FOR THE DEVELOPMENT OF THE BASELINE STUDY ON ACCESS TO FINANCIAL SERVICES FOR PERSONS WITH DISABILITIES

#### **CALL FOR CONSULTANTS**

## Introduction

The Lesotho National Federation of Organisations of the Disabled (LNFOD) is implementing a three-year program, "Capacity development for the promotion of the rights of persons with disabilities" with the financial support from Diakonie Austria whose back-donor is Austrian Development Agency.

One of the key envisaged activities of this program is to conduct a baseline study to determine the level of existing inclusion of people with disabilities living in the program area in the economic, livelihoods programs, access to financial services for the establishment of income generating activities provided by the Public and Private Institutions including Civil Society Organisations.

The purpose of the study is to inform the interventions on economic empowerment of persons with disabilities to be undertaken by LNFOD as a means of improving the livelihoods conditions of persons with disabilities living in the program area.

## **OBJECTIVES AND ACTIVITIES OF THE CONSULTANCY**

The objective of the baseline is to determine the economic situation of persons with disabilities living in the program area with the aim of providing appropriate interventions.

The baseline will therefore serve as a basis for the interventions to be undertaken by LNFOD for the beneficiaries with disabilities living in the program area.

The qualified consultant will therefore undertake the baseline study to assess the existing inclusion of people with disabilities living in the program area in terms of access to economic empowerment programs including access to financial services, income generation for their families.

SCOPE OF WORK

Determine the economic empowerment of people with disabilities living in the program area in terms of access to income generation, job opportunities, and financial services provided by the macro finance institutions/organisations.

Assess and recommend the type of small scale businesses persons with disabilities can run in order to improve their livelihood conditions.

Determine available vocational, commercial and social skills among the beneficiaries which may assist them to establish the income generation activities.

Produce the final baseline study report on economic situation of persons with disabilities living in the program area.

# **KEY QUALIFICATIONS AND ATTRIBUTES**

Advanced Degree in Business Administration and at least five years In-depth knowledge of the sector and issues therein and a good understanding of the issues in the context of Lesotho or region. The consultant must have excellent writing skill, good research and analytical skills. Fluency in both Sesotho and English is a requirement.
