About the position

At the 2018 GDS, thee World Bank committed to: "Ensuring that 75 percent of WB-financed

social protection projects are disability-inclusive by 2025." In its work to achieve this

commitment, the Bank has developed guidance for staff on key elements of an inclusive

social protection project. In the Bank's draft Disability-Inclusive Social Protection Note, it

highlights four entry points for disability-inclusive projects: stakeholder engagement,

disability inclusive analysis, inclusive project design, and measurement of disability

indicators. The inclusive project design pillar states: "Social Protection projects should design

at least one activity to address the issues already identified through the analysis and

stakeholder engagement. The actions can include, both measures to ensure full participation

in the project by persons with disabilities on an equal footing with others and specific

measures targeted to benefit and empower persons with disabilities.

It is against this background that LNFOD and its partners are advocating for the

implementation of the meaningful inclusion and participation of persons with disabilities in

the World Banked social protection funded projects in Lesotho to achieve the said objectives.

LNFOD therefore seeks a programme officer to strengthen LNFOD capacity in the

monitoring of the social protection World bank funded projects in Lesotho.
