# **REQUEST FOR APPLICATIONS**

Lesotho National Federation of Organisations of the Disabled (LNFOD) is seeking a qualified Consultant to conduct external evaluation of the project implemented in the Maseru district, but there was only one activity which was implemented in four districts namely; Mafeteng, Mohale's hoek, Berea, Leribe and Butha-Buthe.

#### **DESCRIPTION OF THE PROJECT:**

The Lesotho National Federation of Organisations of the Disabled (LNFOD) seeks support to enforce inclusive education rights of learners with disabilities especially children through litigation, advocacy and sensitization. This grant is preceded by a recent study conducted by LNFOD with OSISA support that documents Lesotho's legal and policy compliance with the UN Convention on the Rights of Persons with Disabilities (CRPD) particularly those that speak to Articles 9 (Accessibility); 12 (Equal recognition before the law); 13 (Access to justice) and 24 (Education). Findings of the study have influenced LNFOD's decision to address challenges that hinder the access to justice of person with disabilities as well as the enjoyment of the right to quality inclusive education.

Through this grant LNFOD is focusing on:

- 1) Advocacy for the amendment of laws particularly those that deny equal recognition before the law and legal capacity of witnesses and victims with disabilities; and enhancing the capacity of Investigators, Prosecutors, and Magistrates to handle cases involving persons with disabilities; and
- 2) Development of an inclusive education policy to support the enrolment of children with disabilities in mainstream primary schools and on the other hand address attitudinal and environmental barriers faced by children with disabilities at regular schools.

The primary goal of the project is to ensure access to justice for persons with disabilities and promote and protect the right to inclusive education in Lesotho.

The specific objectives are:

- To advocate for and support the domestication and implementation of Article 12 and 13 of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD).
- 2. To support implementation of the right to inclusive education and development of an inclusive education policy for Lesotho.

#### **OBJECTIVES AND ACTIVITIES**

The objective of the external evaluation is to assess the extent to which the project has achieved its objectives and results as articulated by the plan.

## **SCOPE OF WORK**

To review the projects reports in order to make an independent opinion on the extent to which the results have been achieved.

To assess the impact of the project on the beneficiaries and service providers who were trained on both access to justice and inclusive education.

Produce draft external evaluation report and the final external evaluation report for the management of LNFOD.

In-depth knowledge of the sector and issues therein and a good understanding of the issues in the context of Lesotho or region. The consultant must have excellent writing skill, good research and analytical skills. Fluency in both Sesotho and English is a requirement.
